Health Guarantee: Initials _____

The seller certifies that, upon receipt, the dog is in good health and has been immunized, dewormed and has had a complete physical according to the accompanying health record from our local Veterinarians at Countryside Veterinary Clinic Lowville NY.

The buyer will take the puppy to a licensed Veterinarian within three business days (excluding weekends and holidays) of receiving the puppy. Please plan accordingly and make your puppy appointment ahead of time. The 9 week and 13 week booster vaccinations are very important and you do not want to be late on vaccines for your new puppy. Failure to have the puppy checked and vaccinated on time by a licensed Veterinarian will cause the health guarantee to be null and void.

The Breeder offers a one year health guarantee against hereditary issues. If a puppy is found to have a health issue attributed to us, the breeder, we will pay for Veterinarian charges up to ½ of the price paid for said puppy. A full veterinarian report including labs and any testing shall be required and supplied to the breeder. The breeder will have verification done by our local veterinarians at Countryside Veterinary Clinic. Failure to provide requested documentation will cause the health guarantee to be null and void.

Maintenance: The buyer agrees to maintain the puppy in good health, provide routine preventative health care including , but not limited to the following:

Annual physical exams by a licensed veterinarian

Rabies vaccinations as mandated by state law

Monthly heartworm preventative

Preventative and proper control of fleas and ticks

Annual DHLP=Parvo and other routine vaccinations

Puppy will be licensed as required by your local state law

Puppy will be kept clean physically and in a clean environment

Spay & Neutering: Initials _____

All of our puppies are sold as personal pets, not for breeding purposes. The buyer shall have their puppy spayed or neutered by their first birthday. Ideal time is between the ages of six months and one year. Please send a copy of completed spay/neuter procedure back to the breeder within 14 days of the procedure.

Spaying/neutering your puppy prevents pregnancy and birth of unwanted puppies. It avoids the need to keep your puppy restrained or kennelled during heat cycles. It keeps your puppy from roaming away from the home in search of a mate. It avoids reproductive problems and reduces the risk of developing reproductive cancers.

Right of First Refusal: Initials _____

If at any time circumstances are such that the buyer cannot keep the puppy, the seller maintains "right of first refusal" to take possession of the puppy and it's properly signed registration papers, with no monies refunded. The term "right of first refusal" means: if the buyer chooses to relinquish ownership of the puppy, the puppy shall automatically be returned to the seller. Under NO circumstances shall the puppy be taken to an animal shelter, humane society, animal broker, pet store, etc. We will NOT refund, in part or in whole, any money or exchange puppy because of you having changed your mind for any reason whatsoever.
